Letter of Administration for Robert T. Clark

(Letter of Administration)

The People of the State of New-York,

By the Grace of God, Free and Independent:

To Harriet S Clark

Send Greeting:

Whereas Robert T Clark

as is alleged, lately died intestate, having whilst living, at the time of his death, Goods, Chattels and Credits, within this State, by means whereof, the ordering and granting Administration of all and singular the said Goods, Chattels and Credits, and also the auditing, allowing and final discharging the Account thereof, doth appertain unto us: And we being desirous that the Goods, Chattels and Credits of the said deceased, may be well and faithfully administered, applied and disposed of, do grant unto you the said the said ~~Robert T Clark~~ Harriet S Clark full power, by these Presents, to administer and faithfully to dispose of all and singular the said Goods, Chattels and Credits – to ask, demand, recover and receive the debts, which unto the said deceased, whilst living, at the time of his death, did belong, and to pay the debts which the said deceased did owe, so far as such Goods, Chattels and Credits will thereto extend, and the law require:

HEREBY requiring you to make, or cause to be made, a true and perfect Inventory of all and singular the Goods, Chattels and Credits of the said deceased, which have or shall come to your hands, possession or knowledge, and the same so made, to exhibit, or cause to be exhibited, into the Office of the Surrogate of the said County of Delaware at or before the expiration of ~~six~~ three calendar months from the date hereof: And Also, to render a just and true account of Administration when thereunto required. And we do, by these Presents, depute, constitute and appoint you, the said Harriet S Clark Administratrix of all and singular the Goods, Chattels and Credits which were of the said Robert T Clark deceased.

In Testimony whereof, we have caused the Seal of Office of our said Surrogate to be hereunto affixed.
